- An applicant may apply only for a single vacancy (by indicating a relevant municipality). In case of violation of the mentioned condition, documentation submitted by an applicant will not be reviewed.
- ▶ If necessary, the Commission is authorized to offer to an applicant, subject to an applicant's consent, implementation of trainer's activity in another area instead of the municipality indicated in his/her application.

Competition program:

- a) The Constitution of Georgia;
- b) The Organic Law of Georgia The Election Code of Georgia.

Required qualifications:

Mandatory:

- a) higher education;
- b) computer program skills (MS Office Word, MS Office Excel, MS Office Powerpoint, Web Services (the Internet);
- c) skills of verbal communication of information, logical thinking and communication skills.

Desirable:

- a) experience of working as a trainer anda/or teacher;
- b) experience of working at the Election administration and/or other practical experience in the electoral field;
- c) certificate of an election Administration Officer;
- d) BRIDGE certificate in electoral field;
- e) ethnic minority languages skills (for providing training at ethnic minority region).

- ▶ Competition documentation should be submitted from March 1 through March 10, 2016, electronically, to the following e-mail: centre@electionreforms.ge;
- Competition documentation that is incomplete and/or filed late will not be considered.

Competition form:

- a) selection of applicants who have been included in the Election Administration Unified Database of Trainers will take place only based on the evaluation of competition documentation submitted by them;
- b) selection of applicants who are not included in the unified database of trainers of the Election Administration will be effected in two stages: based on 1) evaluation of competition documentation submitted by them and 2) based on interviews with short-listed candidates.

Attention!

An individual selected following a competition, over the period of implementing trainer's activity, should be independent, conscientious and impartial. Trainer shall refrain from such action that may be perceived as an action in support/against any party. The breach of the mentioned requirement will result in termination of an agreement with such trainer.

Competition schedule:

- ▶ Competition announcement: March 1, 2016;
- ▶ Timeframe for submitting competition documentation: March 1 through March 10, 2016;
- ▶ Review of competition documentation: March 14-21, 2016;
- ▶ Interview: March 23-25, 2016;
- ▶ Competition results: March 25, 2016.

Note:

- Applicants will be notified about competition results via e-mail to their e-mail address. Information about selected candidates will also be posted on the official website of the Training Center: www.electionreforms.ge
- ▶ The trainers selected following the competition will undergo a preparatory course prior to the implementation of the training course. The period of implementation of this preparatory course is March 28-30, 2016 (taking the course is mandatory. This course will be held in Tbilisi, travel costs associated for participating in the course will be borne by a participant).
- Candidates selected based on competition will be enrolled in the Election Administration trainers' base or a reserve list and the Center of Electoral Systems Development, Reforms and Training, LEPL may also use the mentioned human resources for the implementation of other awareness-raising and training programs.
